### 2017 Rule Changes

Changed wording to cover age requirements and deleted graduation exclusions for participating at the county fair:

4-H /FFA members eligibility: Exhibitors in the divisions of this department must be bona fide members of Colorado 4-H & FFA whose project work (must be 4- H/FFA members' own work and sources must be sited, plagiarism will not be tolerated). In addition, exhibitors must be at least eight years of age and must not have reached their 19th birthday as of December 31 of the current enrollment year and must satisfy other eligibility requirements (if specified) for a class, to compete in that class. The exhibit may not be shown in another county fair.

### CODE OF CONDUCT Custer County 4-H and FFA Fair Code of Conduct and Disciplinary Procedure

Please retain this document for your information. Please sign that you the 4-H or FFA member and parent/guardian has read, understood and agreed to the rules and consequences listed on this document.

### I.Purpose and Application:

A. The 4-H and FFA Code of Conduct is intended to foster a safe environment that is conductive to optimal learning and growth. Toward that end youth participants are expected to behave in a way that respects the rights and property of others and that will not disrupt or interfere with the 4-H or FFA program goals.

B. This 4-H and FFA Code of Conduct and Disciplinary Procedure is a condition of participation in the Custer County Fair.

### II. Behaviors Prohibited at the County Fair

A. Possession, selling, and/or use of alcoholic beverages, tobacco products, and illegal drugs OR being present where individuals are using alcohol, tobacco products and/or any illegal substances.

B. Abuse (physical and/or verbal) and harrasment

C. Any kind of public display of affection.

D. Possession of weapons or firearms (except while participating in a Shooting Sports Event)

- E. Behavior that violates state or local laws
- F. Damage to property of others
- G. Theft, misuse or abuse of public or personal property
- H. Conduct that jeopardizes the safety of self or others
- I. Conduct that disrupts or interferes with the 4-H or FFA programming

J. Inappropriate dress- Clothing should meet the standards expected in public schools

K. It is expected that the exhibitor is the primary caretaker of the animal.

III.Fairboard, 4-H Leaders, FFA Advisor and Advisory board members, Superintendents, County or State Extension personnel may impose discipline pursuant to Part IV below in cases of misconduct by current, former, or prospective 4-H participants if, in the judgement of the personnel, the misconduct poses a potential risk to the 4-H or FFA program. This includes risks to the safety or well-being of others and risks to the effective functioning or integrity of 4-H and FFA.

### IV. Disciplinary Procedures

A. Discipline may be imposed by any 4-H or FFA staff who has oversight responsibility at the Custer County Fair.

B. Unless immediate action is required, the following procedures must take place before there can be any finding or conclusion of guilt:

1. The accused participant shall be told the charge (which of the prohibited behaviors listed above) he or she is accused of violating, and

2. The accused participant is told what factual evidence supports the charge, and

3. The accused participant is given a chance to tell his/her side of the story.

C. The 4-H or FFA staff person/s must be satisfied that the participant, more likely than not, engaged in the prohibited behavior before imposing a sanction

- D. Sanctions may include some or all of the following:
- 1. Verbal warning
- 2. Notification to parents
- 3. Immediate removal from the fair
- 4. Being placed on a behavior contract
- 5. Referral to local law enforcement and/or juvenile court
- 6. Program suspension and/or
- 7. Expulsion from the fair

8. Other sanctions appropriate to the circumstances, as determined by fairboard, 4-H staff, FFA personnel.

E. Protest and Appeals

1. A "protest" may be used by anyone to review rules, policies and judging procedures. All protests shall be considered by the Superintendent or the entity responsible (i.e. the Fair Board), as appropriate.

2. The protest must be in writing, on a Protest Form obtained from the Fair Board Office and accompanied by a fee of \$50 in cash or certified check. The protest shall plainly state the cause of the protest and shall be delivered to the Fair Board Office no later than 24 hours after the occurrence of the alleged incident. Judging will not be interrupted by a protest.

3. In the event the protestor is not satisfied by the protest resolution, the protestor may appeal the protest resolution to the Fair Board Executive Panel.

4. The appeal must be in writing, on an Appeal Form obtained from the Fair Board Office, and accompanied by a fee of \$100 in cash or certified check. The appeal shall plainly state the matter being appealed and shall be delivered to the Fair Board Office no later than 8(eight) hours after the protest resolution was announced. The decision of the Fair Board Executive Panel is final.

5. Compliance with this protest and appeal process is mandatory prior to seeking review in any other forum. The fee(s) imposed above shall be refunded if the matter is resolved in favor of the person bringing the protest or appeal.

F. Immediate action situations:

1. 4-H, FFA, or Extension staff may take immediate action to remove a participant from the fairgrounds and other action as needed, where there is an emergency situation or significant risk of continuing misconduct. In those cases, the immediate action is temporary discipline and 4-H, FFA, or Extension staff must arrange for the procedures in parts B,C,D, and E above as soon as possible but in no event longer than seven days from the temporary discipline.

1. 4-H /FFA members eligibility: Exhibitors in the Divisions of this department must be bona fide members of Colorado 4-H & FFA whose project work (must be 4-H/FFA members' own work and sources must be sited, plagiarism will not be tolerated). In addition, exhibitors must be at least eight years of age and must not have reached their 19th birthday as of December 31 of the current enrollment year and must satisfy other eligibility requirements (if specified) for a class, to compete in that class. The exhibit may not be shown in another county fair. 2. 4-H/FFA members must wear appropriate clothing while exhibiting their projects according to 4-H Dress Code. 3. JUDGES DECISION IS FINAL! The Danish system will be used on the 4-H Consumer Science and General Division and all open classes shown in the Exhibit Building.

4. Judged interviews are required for all Consumer Science and General projects.

5. 4-H projects that qualify to go to the State Fair will be determined by the judge. These projects will be awarded State Fair Quality Stickers.

6. Protests must be made in writing and presented to the Fair Board President by July 31st of the current year.
7. Exhibits, record books and ribbons must remain on the

grounds until 7:00 AM, Monday, July 24, 2017.

Exceptions: Any exhibit, record book or ribbon may be

released at the discretion of the Superintendent.

8. 4-H e-records may be completed by pencil, ink or

computer. The choice will not affect judging.

9. All exhibits must have the name, address and county of the exhibitor on a 4-H or FFA display card.

10. If projects are divided by Juniors and Seniors age groups, the ages are Juniors 8-13 and Seniors 14-18. If projects are divided by Juniors, Intermediates and Seniors age groups, the ages are Juniors 8-10, Intermediates 11-13 and Seniors 14-18.

 Associate member 4-H projects will be judged separate from all other exhibits in all classes in all divisions.
 No project will be exhibited in an unsafe manner or with

unsafe equipment.

13. Fairgrounds clean-up will be held immediately before the Fair and on Monday, July 20, 2017. It is expected that the grounds will be kept as clean as possible during the Fair.

### PREMIUMS

All 4-H Consumer Science, General and Non-Sale animal projects are eligible for premiums. Blue or  $1_{st}$  place premiums - \$8.00 Red or  $2_{nd}$  place premiums - \$5.00 White or  $3_{rd}$  place premiums - \$4.00 Yellow or  $4_{th}$  place premiums - \$3.00

GENERAL RULES

1. Judged interviews are required.

### CAKE DECORATING

### Project Exhibit Rules

1. Cake should be placed on a very firm, disposable surface, cut parallel to the shape of the cake and must be  $1\frac{1}{2}$  " on each side from the base of the order, not the cake. The surface should be covered. Freezer paper is not advised because it absorbs grease. The cake board must be covered with a food safe material -such as aluminum foil. If you use a decorative or gift wrap paper or fabric, it must be covered in food quality plastic wrap. 2. It is recommended that members learn the basic cake decorating skills included in Units 1-3 before taking any of the more advanced units. Youth may then select the unit which includes the skills they wish to learn. Units 4-6 do not have to be taken in order as numbered and are for Jr., Int. and Seniors. Units 7-9 do not have to be taken in order as numbered and for Intermediates and Seniors. Units 10-12 are for Senior members only.

3. Real cakes are required for Units 1-6. Cake forms are preferred for Units 7-10, as they hold up better under state fair conditions.

4. No non-edible material can be used in Units 1-6.

5. Lower Units (1-3) in Cake Decorating should not use Royal Icing or Rolled Fondant as the base frosting.

Display boards are made of lightweight cardboard and are sturdy, attractive, inexpensive and available at most local stores. They come in several colors. When opened, the 1 foot wide winged sides provide a surface to help the exhibits stand alone on a table top. 4-H projects are to use the standardized display board size of 4ft. X 3ft.

No headers or attachments are allowed on the display boards.

Fondant may be used only for decorations on cakes in Unit 1. No fondant can be used in Units 2 and 3. Only required tip work can be used in Units 2 and 3.

6. Exhibit requiring over 2'x2' exhibit area must be checked with the superintendent.

7. Cakes will not be cut for judging.

8. Real cakes are required for all four required cakes and cupcake batter in units 1-6. At least 2 of the cakes need to be real in Units 7-10. Also for Unit 8, 3 of the 5 cakes are required to be totally covered with fondant.

9. Unit 11 is molds and three molds are required plus the exhibit mold for a total of 4.

10. Unit 12 - 75 percent of the judging will be on the notebook.

11. All cakes require a bottom border.

12. Definition of two layered cake is, two of the same size cakes placed on top of each other. This is used for units 3,7, 8 & 9.

### Unit 1 – Edible Cake Decorating – Jr., Int., & Sr.

Exhibit will consist of the following:

A. Completed Cake Decorating e-Record presented in a sturdy binder/notebook.

B. Include the following information in the Cake Decorating e-Record on the four required cakes plus the exhibit

(TOTAL of 5) (All 5 cakes must be real cakes):

1. occasion for use

2. size or shape

3. real cakes

4. techniques used

5. edible materials used

6. cost to buy similar cake

7. any problems you had

Be sure to put the cost of your four cakes and exhibit cake in the expense page in the e-Record.

C. Include photos or drawings of the four required cakes in addition to photos of you working on your project in the record photo page.

D. One decorated single layer real cake (8' or 9" round or square or 9"x13" rectangle cake) using only edible materials for example: candies, pretzels and coconut should be used to create a design. A real cake, no cake forms, should be used for exhibit in Unit 1. No decorator tips are allowed in this unit. Fondant may be used for decorations only on the cake. One fourth of the top of cake should be visible to show smooth base. No royal icing can be used as icing or decorations on the cake. No non-edible material can be used in units 1-6. E. Bottom base border required. F. Project will be evaluated on the quality of the information completed in the e-record (25 percent) and quality of the exhibit (75 percent).

### Unit 3 – Two-Layered Cake – Jr., Int., & Sr.

Exhibit will consist of the following:

A. Completed Cake Decorating e-record presented in a sturdy binder/notebook.

B. Include the following information in the Cake Decorating e-record on the four required cakes plus the exhibit (Total of 5)

(All 5 cakes must be real cakes):

1. occasion for use

2. size or shape

3. real cakes

4. techniques used

5. tips used and where

6. cost to buy similar cake

7. any problems you had

Be sure to put the cost of your four cakes and exhibit cake in the expense page in the e-record.

C. Include photos or drawings of the four required cakes in addition to photos of you working on your project in the record photo page.

D. One decorated two-layered real cake (8" or 9" round or square) using three to five different types of tips in decorating.

You must use the writing, star and leaf tips, but may also use other tips, if you choose. Spatula and brush striping are optional. One fourth of the top of cake should be visible to show smooth base. Do not use flowers made on a flower nail or materials other than frosting. No fondant or royal icing may be used as icing or decorations on the cake. Only required tip work can be used in Unit 3. No non-edible material can be used in units 1-6.

E. Figure piping required on Exhibit Cake and on at least two practice cakes.

F. Side border required on Exhibit Cake and on at least two practice cakes.

G. Bottom Base Border required.

H. Project will be evaluated on the quality of the information completed in the e-record (25 percent) and quality of the Exhibit (75 percent).

#### CLOTHING CONSTRUCTION Project Exhibit Rules:

1. All exhibit garments must be labeled with name, age, county and unit of the 4-H member. Labels must be attached at the inside of the neckline or at the waistband of skirts and pants. Information must be written or typed on a label and securely attached to inside of garment. This will assist in case of property loss.

2. The garments may be worn before exhibiting but should be in good and clean condition.

3. In Units 1-4, sergers may be used as a seam finish, only; not as a seam.

4. Due to the difficulty of skills involved, buttonholes and button loops are to be used in Unit 4 and above ONLY.
5. In Units 2-4, clothing is defined as wearable, dressy or casual wear, active/sportswear or sleepwear. An exhibit shall consist of no more than three coordinated pieces. No accessory items, i.e. shoes, scarves, hats, etc., (except Unit 1 if using a pattern from the manual).
6. Advanced Units 21-28 – complete one textile experiment using your garment fashion fabric each year. Include this information in your clothing construction e-record: completed experiment sheets and sample(s) mounted (on 8 ½"x11" heavy paper). No photos of experiments are allowed. Fabric must be attached. Experiments may be repeated in a subsequent year as long as different fabric is used.

7. Pattern instruction sheet is required and must be attached securely to the e-record. Write name and county on pattern instruction sheet.

8. Do not use binders that are clear plastic with sliders.9. Members are encouraged to select a unit that challenges their skills. All units will be judged on required skills included in the manual.

10. All garment construction in clothing units 1-4, 8, and 21-28 are to be made for the member with the exception of Unit 7 – Sewing for Others.

### Unit 1 – Beginning Clothing – Jr., Int., & Sr.

Exhibit will consist of the following:

A. Completed Clothing Construction e-record with pattern instruction sheet (not needed if using pattern from manual) presented in a sturdy binder/notebook. Include in your story why you chose a clothing project, why you selected this garment or outfit and describe any changes made in the garment or outfit.

B. Provide the brand, number and cost of the pattern used in the Clothing Construction e-record on the Expense page.

C. Include the following information on the Clothing Construction page:

1. A list of all the garments or articles made

2. Percent of fiber content of each garment or article made

3. Care of garment exhibited

D. Include the cost of each garment in the Expense record of the Clothing Construction e-record.

E. One article or item illustrating the skills learned in Unit 1. Exhibits must use a firmly-woven, medium-weight cotton or at least 50-percent cotton-blend fabric. Exhibit should be a simple pattern with two or three pattern pieces.

Exhibit should not include zippers, buttons and buttonholes or other closures, facings, interfacings or use of bias.

F. Project will be evaluated on the quality of the information completed in the e-record (25 percent) and quality of the Exhibit (75 percent).

### FOODS AND NUTRITION Project Exhibit Rules:

1. Include a copy of the recipe used, attached securely to the e-record. No commercial mixes are to be used.

2. Only completed e-records and canned goods will be returned.

3. Food items that show signs of mold growth or need refrigeration to be safe to eat at time of judging will not be accepted.

4. Bring food items on sturdy white paper plates and/or covered heavy cardboard in a zipper-locked bag for display of food exhibits when possible. Plates and pans will not be returned. Food items should be covered securely.

5. MyPlate information is available at the Colorado 4-H web page at: www.colorado4h.org under Foods and Nutrition page.

6. Bacon is not acceptable in baked goods because the heat during the cooking process might not penetrate the meat thoroughly enough. Large pieces or chunks of cheese on or in the recipes where there is a large proportion of cheese is not acceptable either.

# Unit 1 – Riddles and Rhymes and Fun Food Times – Junior, Intermediate and Senior

Exhibit will consist of the following:

A. Completed e-record with exhibit item recipe presented in a sturdy binder/notebook.

B. Include the following information on the Foods and Nutrition page:

- 1. Foods prepared
- 2. Number of times
- 3. Special Concerns

C. Four baked, drop or molded cookies of one recipe. (Molded cookies are also made from a stiffer dough that is molded into balls or cookie shapes by hand before baking. Snickerdoodles are an example of molded cookies).

D. Project will be evaluated on the quality of the information completed in the e-record (25 percent) and quality of the exhibit (75 percent).

### Unit 22 – Baking – Junior, Intermediate and Senior

Youth can choose to exhibit in either one or both classes – Coffee Cake or Bar Cookies

### Coffee Cake -

Exhibit will consist of the following:

A. Completed Baking e-record and recipe presented in a sturdy binder/notebook.

B. Include the following information on the Baking page:

- 1. Foods prepared
- 2. Number of times
- 3. Special concerns

C. Answer the following questions on the Baking page:

1. What did you learn about the ingredients used in

baked products and what is their importance?

- 2. What adjustments did you make for altitude?
- 3. What food related career did you learn about and how?
- D. One non-yeast coffee cake.

E. Project will be evaluated on the quality of the information completed in the e-record (25 percent) and quality of the exhibit (75 percent).

### Bar Cookies -

Exhibit will consist of the following:

A. Completed Baking e-record and recipe presented in a sturdy binder/notebook.

B. Include the following information on the Baking page:

- 1. Foods prepared
- 2. Number of times
- 3. Special concerns

C. Answer the following questions on the Baking page:

1. What did you learn about the ingredients used in

baked products and what is their importance?

2. What adjustments did you make for altitude?

3. What food related career did you learn about and how?

D. Four bar cookies of one recipe.

E. Project will be evaluated on the quality of the information completed in the e-record (25 percent) and quality of the exhibit (75 percent).

### HERITAGE ARTS

 All exhibits must have the name, age and county fo the 4-H member attached. Information must be written on

Cloth and attached securely to each garment/piece. 3. It is to the member's advantage to include in the record a

band from the skein of any commercial yarn or thread used in the project. This is helpful to judges when evaluating the project.

4. All exhibits using patterns must have the pattern or a clear copy securely attached to the record, as this is useful to the judges when evaluating the project.

5. Members are encouraged to select a project that challenges their skills. There are no specific requirements for exhibit items. Quilts do have size requirements.

6. All workmanship in Heritage Arts projects must be done by the member. All piecing and quilting must be done by the member.

7. Miscellaneous Fiber Art classes will include Spinning, Weaving, Ethnic Arts, Rug Making and Macrame.

Note: All exhibits are limited to those that use fiber or fabrics with the exception of Miscellaneous Heritage Arts – Non Fiber.

Note: Small (less than 6"x6") or delicate items should be mounted on an 8"x10" foamcore board.

### Miscellaneous Heritage Arts – Fiber – Macrame – Junior, Intermediate & Senior

Exhibit will consist of the following:

A. Completed Heritage Arts e-record presented in a sturdy binder/notebook.

B. Include the following information on the Heritage Arts page:

1. Brief history report about the specific craft you selected:

a. Where did it begin?

b. How did it start?

c. Why was it started?

2. List references used:

a. Juniors (8-10) one or two references

b. Intermediate (11-13) two or three references

c. Senior (14 and older) three or more references

3. If pattern was used, secure a copy of the pattern to the e-record.

C. One piece or a set of up to three coordinated pieces, comprised of a minimum of 50 percent yarn/fabric illustrating skills learned. Can be ethnic-specific to a culture, country or region. (Example: weavings, spun skeins, felted bags, batiked fabric, hooked pillows, Navaho rug, etc.)

D. Project will be evaluated on the quality of the information completed in the e-record (25 percent) and quality of the exhibit (75 percent).

GENERAL RULES

1. Judged interviews are required.

### ENTOMOLOGY

### Project Exhibit Rules:

1. Older members may start with Unit 2.

2. Each year 4-H members build on their collection by adding new insects as required for the particular unit. Refer to the exhibit requirements for the number of insects to collect for that unit.

3. Acceptable sizes of hand made Entomology Display Boxes taken from the manual and kit:

12" W x 16" L x 3" Deep

12" W x 18" L x 3 ½ " Deep

18" W x 24" L x 3 ½" Deep

4. Glass tops on entomology display cases should slide to the top or side of the case to prevent them from slipping out and breaking when placed on display.

5. Commercially available display cases are acceptable.

6. Regular insect pins are required in all units.

7. On Units 2 through 7, records must include date and location where insects were collected. Place this information on labels attached to insect pins.

## Unit 1 – Let's Learn About Insects – Junior, Intermediate and Senior

Exhibit will consist of the following:

A. Completed e-Record and Entomology workbook presented in a sturdy binder/notebook.

B. Insect Collection display no fewer than 10 and no more than 35 adult insects in at least 3 different correctly labeled orders. Boxes for display should be approximately 12" x 16" x 3". Regular insect pins are

required.

C. Project will be evaluated on the quality of the information completed in the e-record (25 percent) and quality of the exhibit (75 percent).

### Unit 4 – Insect Identification and Community Projects – Junior, Intermediate and Senior

Exhibit will consist of the following:

A. Completed e-Record and Entomology workbook

presented in a sturdy binder/notebook

B. Insect collections – display no fewer than 100 and no more than 250 insects in 10 different, correctly labeled orders.

Standard-sized display boxes with removable glass

covers are required. Regular insect pins are required. C. Project will be evaluated on the quality of the information completed in the workbook and e-record (25 percent) and quality of the exhibit (75 percent).

### LEATHERCRAFT

### Project Exhibit Rules for All Units:

1. Put name, age and county on back of exhibit board or on tag attached to individual exhibit articles.

2. Indicate in e-record whether articles are made from kit or are self-cut and designed by the member.

3. A set means a number of things of the same kind that belong, or are used together (i.e. six matching

coasters, belt and buckle with matching designs, etc. 4. Advanced leathercraft members Units 4-10 may exhibit in more than one of the classes, provided the member is enrolled in and has completed the requirements of the units exhibiting in.

5. Unit 8 is now an advanced creative stamping. It is recommended that 1st year juniors take Unit 1 intro to stamping before taking Unit 8.

6. Definitions:

Carving – is where you cut into the leather (usually swivel knife) as part of the design you are tooling.

Stamping/Tooling – is where you use impressions made from tools to form a design.

Cord – is round and waxed thread.

Lace – is flat with a shiny side and rough side.

Background Dyeing – dyeing a solid color to the area tooled with the backgrounder.

Solid Color dyeing – is where you dye the whole project the same color. For example, you tool a belt and then dye it all black, or you make a book cover and dye it all one color.

Color shading – is where you use shades of color to make the design look more realistic. For example, you can use darker and lighter shades of a color on a

flower you have tooled to make it look realistic, or an animal or figure of any kind.

Staining/Antiquing – using an antique finish like saddle tan – apply & remove/rub on & wipe off.

Clear finish – is a finish that has no color in it. For example, oil (no color added), leather finish spray or wipe on that has no color mixed in it.

### Unit 1 – Introduction to Leathercraft & Creative Stamping – Junior, Intermediate and Senior

Exhibit will consist of the following:

A. Completed e-record presented in a sturdy binder/notebook.

B. Exhibit three (3) articles Place the exhibit items on a board  $12^{\circ}x18^{\circ}x1/8^{\circ}$  or  $\frac{1}{4}^{\circ}$  (preferably pegboard) to which items are attached by means of lacing or thread: One each from categories below:

1. One article or one set of articles on flat leather with no lacing or stitching. Examples: bookmark, wrist bracelet, set of coasters.

2. One article with at least two pieces of leather that are sewed together with lace using a whip stitch or running stitch.

Pre-cut kits or self-cut leather may be used. Examples: key case or knife sheath.

3. One article with at least two pieces of leather that are sewed together with cord stitching. Use precut kits with pre-punched holes. Example: coin purse.

C. Apply a clear finish to complete your article.

D. Project will be evaluated on the quality of the information completed in the e-record (25 percent) and quality of the exhibit (75 percent).

Note: No carving, solid-color dyeing, color shading and or antiquing is permitted.

#### MODEL ROCKETRY Note to all units:

1. Rocket exhibits must relate to the skill level for the unit entered. Units 1-4 should include the color picture of the rocket and skill level title from the rocket-kit package as part of their record book. All project material must be organized and secured in a sturdy binder/notebook. Unit 6 must have a copy of the plans or blueprints including instructions "step by step" to build the rocket.

2. Fins must be balsa wood (balsa and basswood) and finished with paint in classes so indicated. No plastic fins for Units 1-3.

3. Fins of plastic or other materials(except metal) must be exhibited in Units 4 and 6 ONLY.

4. Unit 4 members may build Skill Level 4 and Skill Level 5 rocket kits.

5 Rockets are to be displayed and held vertically by a substantial rod or support no taller than the rocket on a stationary base appropriate to the size of the rocket not to exceed 12"x12"x1" thick. Only the rocket will be judged. Do not decorate the base. No triangular stands can be used for displaying the rocket.

6. Do not include live or expended engines in the rocket exhibited.

7. If rocket is damaged in launching, it can still be judged for quality of construction, e-record and pictures.

8. Display rockets cannot be used for Rocket Fly Day competition.

9. No launching pads should be used for displaying the

rockets.

10. All rockets must be exhibited upright.

11. Launching your rocket is not a requirement. It is a good idea, however, to make 2 rockets – one for exhibit and one to launch if possible.

Unit 1 – Introduction to Rocketry – Junior, Intermediate and Senior

Unit 3 – Intermediate Model Rocketry – Junior, Intermediate and Senior

#### **BALSA OR BASSWOOD FINS ONLY** Both Exhibits will consist of the following:

B. On the Model Rocketry page enter the rockets you built

in this unit. Include the following information:

1. Model name; skill level: from a stock kit, modified kit

or self-designed-and-built.

1. Model name; skill level; from a stock kit, modified kit or self-designed-and-built.

2. Power: single-stage, multi-stage; cluster.

3. The fuselage: single-tube or glider rear-engine or glider front-engine or glider canard.

4. Engine information: engine code, label color, and type of recovery system.

C. If the rocket was launched provide the following information on the Model Rocketry page:

1. Number of times successfully launched; kind of

Label and use captions to make your display as educational as possible. The standardized display board size of 4 ft. x 3 ft. is to be used with 4-H projects. No additional items may be included in front of display board.

C. Project will be evaluated on the quality of the information completed in the e-record (25 percent) and quality of the exhibit (75 percent).

List the day, month and year for the date of completed activities on page 4.

### PHOTOGRAPHY

### **Project Exhibit Rules:**

1. For all units, submit photo material for the current unit being entered. Do not submit previous photos or records. 2. In Levels 1-3 – pictures can either be mounted on the journal pages or on card stock. Use the tips on page 73 of the manuals for mounting the pictures.

3. Display photo may be up to 5" x 7" in size. The photo must be mounted on a mat and suitable for hanging without additional frame. No other mounted materials (i.e., glass, wood, plastic, metal, etc.) can be used.
4. All photos in the notebook or manual should be 4"x6"

unless otherwise indicated in the manual. If the photos do not fit on the page, add a page for the photo.

5. Display photo will be used to display at state fair so be careful when picking your best photo. Notebooks will not be displayed.

6. The maximum size for the matted only picture is no larger than 8"x10" (no frame or glass).

7. Binder/notebooks: Use a hardback, three-ring notebook up to 3 inches in size for all units. No posters or oversized books. Do not use plastic covers on any pages in the unit. All materials must fit within the notebook. Additional pages can be added as needed to exhibit your photos. Notebooks will be judged but will not be displayed.

8. Videos must be appropriate for total family viewing.

9. For photo exhibits in levels 1-3 follow the tips on page 73 on the manuals. Photos can be mounted on the journal pages or card stock. Label format for Units 1-4:

2. There is one E-record that contains the inventory sheet and the discipline log records for all the disciplines that are required for this project.

3. Display should illustrate a chosen aspect of skill areas.

This is separate from the statewide State Fair Shooting Sports Event. The standardized display board size of 4 ft. x 3 ft. is to be used. No additional items may be included on or in front of display board. No wooden display cases.

4. Counties may enter only one exhibit per class. Members may have entries in both the display board classes and the stand-alone classes

5. No live ammo, broadheads, knives or functional firearms are allowed to be displayed.

6. Do not use the word weapon when creating your display. Make sure that there are no safety violations in your display. (Example: no earplugs, no safety glasses on a photo of a youth firing his/her gun.)

7. Stand-alone items are items that are made to enhance the discipline, such as a quiver, gun case, gun stand, etc. No display boards are allowed in the Stand-Alone Classes.

#### All Units – Archery, Air Rifle, Archery, Shotgun, .22, Muzzleloading - Junior, Intermediate and Senior All exhibits will consist of the following:

A. Completed e-Record for the discipline exhibited presented in a sturdy binder/notebook.

B. Specific discipline e-Record is required.

C. A Discipline Record Log Sheet is required.

D. Exhibit may be a display board **or** a stand-alone item, such as gun stocks or decoys. Display items that illustrate something learned in the project this year. The standardized display board size of 4 ft. x 3 ft. is to be used. No additional items may be included on or in front of the display board.

E. Project will be evaluated on the quality of the information completed in the e-record (25 percent) and quality of the exhibit (75 percent).

B. A display board illustrating a topic investigated during the project year. The standardized display board size of 4 ft. x 3 ft. is to be used with 4-H projects. No additional items may be included in front of display board.

C. Project will be evaluated on the quality of the information completed in the e-record (25 percent) and quality of the exhibit (75 percent).

### VISUAL ARTS

Portfolio Pathways – Painting, Printing and Graphic

### **Design – Junior, Intermediate and Senior**

Exhibit will consist of the following:

A. Completed e-record in a sturdy binder/notebook.

B. Complete a minimum of two art techniques listed under the media of Painting, Printing or Graphic Design.

Provide pictures of all completed art techniques on the Visual Arts e-record. (Art techniques for painting:

acrylics, watercolors, abstracts, sand paining, selfportrait, action painting, oil painting with impasto,

scumbling and perspective and encaustic painting. See manual for printing and graphic-design techniques.)

C. Explain in your 4-H e-record story what you learned. D. Exhibit – display your best art design. Oil paintings and acrylic paintings should - be no larger than 16"x24" frame and ready to hang (no frames should be used.) Watercolor paintings should use small matte and be

framed with glass. The framed watercolor should not be larger than 16"x24".

E. Graphic Design exhibit can be a logo or a self-portrait, a blog, advertisement, website, CD or DVD label, optical illusion, or a notebook of your graphic designs, etc.
F. Project will be evaluated on the quality of the information completed in the e-record (25 percent) and quality of the exhibit (75 percent).

### Sketchbook Crossroads –Drawing, Fiber and Sculpture-Junior, Intermediate and Senior

Exhibit will consist of the following:

A. Completed e-record presented in a sturdy binder/notebook.

B. Complete a minimum of two art techniques listed under the media of Drawing, Fiber and Sculpture. Provide pictures of all completed art techniques on the Visual Arts e-record. (Art techniques for Drawing: continuous and contour, shading,perspective, paper choices, colored pencils, pen and ink, calligraphy and cartooning.) See manual for fiber and sculpture techniques.

C. Explain in your 4-H e-record story what you learned.

D. Exhibit – display your best art design or sculpture. Framed drawing shall be no larger than16"x24" including the frame and ready to hang. Fiber art should be framed and ready to hang and no larger than 16"x 24". (Ready to Hang for pictures means – wire secured and

### heavy enough to hold the picture. NO TAPE!!!)

E. Project will be evaluated on the quality of the information completed in the e-record (25 percent) and quality of the exhibit (75 percent).

### WILDLIFE

Unit 3 – Wildlife Conservation – Managing in a World with You and Me – Junior, Intermediate and Senior All exhibits will consist of the following:

A. Completed Wildlife e-record presented in a sturdy binder/notebook.

B. Include the following information on the Wildlife page. Show what you did and learned. Show evidence of your personal field experiences, study or observations. C. A display board showing educational information about a topic of interest related to wildlife. Follow the standardized display board size of 4 ft. x 3 ft. No additional items may be included in front of display board. Possible topics could include but not restricted to: species found in Colorado, wildlife habitats, role of predators, types of bird feed, or urban wildlife challenges.

D. OR instead of a display board, exhibit may be a standalone item, such as a wildlife diorama, scrapbook with wildlife information, pictures and news, a bird feeder or bath, or wildlife track molds. Display items should illustrate something learned in the project this year.
E. Project will be evaluated on the quality of the information completed in the e-record (25 percent) and quality of the exhibit (75 percent).

### 4-H & FFA LIVESTOCK AND SMALL ANIMAL DIVISION GENERAL RULES

1. 4-H /FFA members eligibility: Exhibitors in the divisions of this department must be bona fide members of Colorado 4-H & FFA whose project work (**must be 4-H/FFA members' own work and sources must be** 

sited, plagiarism will not be tolerated). In addition, exhibitors must be at least eight years of age and must not have reached their 19th birthday as of December 31 of the current enrollment year and must satisfy other eligibility requirements (if specified) for a class, to compete in that class. The exhibit may not be shown in another county fair.

 4-H & FFA members must wear appropriate clothing while exhibiting their projects and during the sale. (Long sleeve shirts/blouses, nice jeans or trousers and closed toe shoes. No sandals, etc.) No Hats. No gum or tobacco.
 JUDGES DECISION IS FINAL! The American system will be used on 4-H and FFA Livestock classes for presenting ribbons. All small animal and livestock open classes will be awarded Participation ribbons.

4. A mandatory cleanup will be held on Saturday, July 9, 2017 from 8 a.m. until the clean up is complete. Failure to make this cleanup will result in forfeiture of twenty percent of the Exhibitor's proceeds from the sale of their animal.

5. All Large Animal Livestock Exhibitors must check with a Fair Board Member before leaving the fairgrounds after cleaning their area. Exhibitors failing to do so will forfeit twenty percent of their proceeds from the sale of their animal. The twenty percent will go into a fund for improvements to the fairgrounds.

6. A mandatory meeting for all market livestock exhibitors will be held immediately after weigh in on Wednesday, July 12, 2017.

7. The Fair Board reserves the right to declare the 2017 Custer County Swine Show an ALL HARVEST SHOW if there is a confirmed case of PEDV in the county.
8. The Barns will close at 10 p.m. with only exhibitors and family members allowed in the buildings to check on the exhibitor's animal.

9. Every animal must be a 4-H or FFA project and must be shown by its owner or another qualified Custer County4-H or FFA member. Superintendents have the authority to deal with hardship cases.

10. All animals must remain on the fairgrounds until released by the superintendents.

11. Breeding records will not be required for any of the breeding classes.

12. All beef, sheep, swine and goat exhibitors should provide the majority of the care of the animal beginning with the Official Weigh-in and to continue through the duration of the Fair. Horse and small animal exhibitors should provide the majority of the care of the animal beginning May 1.

13. After weigh-in and/or placement of animals at the Fair, the member must do the major grooming and showing of the animal with minimum assistance from parents, leaders or any other outside help.

14. Each exhibitor is responsible for cleaning up their own stall area and must be checked out by a Superintendent or the project leader at the end of the Fair. **No straw or hay is allowed for bedding.** 

### nay is allowed for bedding.

15. Space priority in the livestock and small animal barns will be given to 4-H and FFA members.

16 To be eligible to exhibit market animals, all 4-H and FFA members are required to attend a Meat Quality Assurance class. New members must attend the class in their first year. Members must again take the class when they turn 14 years of age and become senior age exhibitors.

17. To be eligible to sell market animals, all exhibitors and parents are required to sign and turn in to the Fair Office, a copy of the Wholesome Meat Act Disclosure.

18. Showmanship is a required class for all 4-H and FFA market livestock, horse and small animal exhibitors.

a. The Champion in the Senior and Junior age divisions of all market livestock & horse projects will compete in the Master Showmanship Contest.

19. A first and last call will be given for all small animals and livestock to be entered into the show ring.

20. All market animals weighed in must show in appropriate classes. This includes animals that do not meet the minimum weight requirements (feeder animals). Exhibitors of feeder animals, at the discretion of the superintendent, will have the option of having the animal released to go home following the feeder class show. 21. Classes will be divided at the discretion of the Superintendents.

22. Animals shown in breeding classes cannot be shown in the market classes.

23. All market livestock must be weighed at the time scheduled. This weight will be used as the sale weight.24. Re-weigh policy: re-weigh for animals that either weigh under the minimum or over the maximum weight(s) for the species will be allowed under the following

guidelines -

A. The animal will be removed from the scale.

B. Animal will not be allowed to leave the immediate area of the scale.

C. Scale will be re-zeroed.

D. Animal will be immediately re-weighed.

E. The second weight recorded will become the official weight.

25. All market beef, sheep, and goats must be in appropriate rate of gain contest.

26. The tag number initially assigned to an animal must remain with that animal throughout the entire fair.

27. All unmanageable livestock will be immediately removed from the fairgrounds.

28. All exhibits are to display good health. Any animal showing evidence of poor health that renders the animal unfit for human consumption may be excused from the grounds immediately following a decision from the review committee.

The review committee shall consist of the animal superintendent, a member of the Fair Board, the Extension Agent or FFA Advisor, and a licensed veterinarian.

29. Each market livestock animal will be checked by a licensed veterinarian during the fair and again prior to the sale to determine if the animal is slaughter ready on the day of the sale.

30. If a market livestock animal is barred from the sale, the exhibitor may sell a qualified alternate enrolled project if they have one *(must meet weight requirements)*.

31. Clarification of contest points scoring system (excludes Horse) – all contest points are earned in the same method –

Using a 10 point scoring system. 1st place receives 10 points, 2nd place receives 9 points, 3rd place receives 8 points and so forth down the line to 1 point. The number of exhibitors doesn't change the point scores. If only two exhibitors are showing, the first gets 10 points and the second place earns nine. Fifteen exhibitors means that 11-15th places receive zero points.

32. No unethical practices will be allowed:

a. Doctoring, doping or injections for body "fill in"

b. Use of ice packs or other refrigerants to alter the quality of the finish of an animal.

c. No altering of color or structure of hair or wool, except for trimming and blocking.

d. Only acceptable product on swine is WATER!

e. All market animals may be subject to random drug testing.

Exhibitors will be limited to selling only two animals of different animal classes (i.e.: 1 beef & 1 lamb; 1 beef & 1 swine; 1 lamb & 1 swine) and one meat pen of rabbits at the Market Livestock Sale. Exception: if the Grand Champion and Reserve Grand Champion of any animal class are owned by the same exhibitor, all the Champions will sell.

3. All Grand and Reserve Grand Champions will sell.

4. Market goats will be allowed to sell provided: a. Market goat (wethers or does) must weigh a

minimum of 55 lbs. and must be milk-tooth goats. 5. The sale order will be determined by class placing,

rotating from light weight to heavy weight. Exception: Grand Champion and Reserve Grand Champion will sell first. Beef sale order will be determined by the judge.

6. The sale weight will be the weight established at the weigh-in.

7. In order to sell Market beef animals, each exhibitor must present a bill of sale to the brand inspector prior to the sale.

8. Market swine must weigh a minimum of 220 lbs. and a maximum of 290 lbs.

9. Market sheep must weigh a minimum of 105 lbs. and no maximum.

10. Market beef must weigh a minimum of 1,000 lbs. and no maximum.

11. All exhibitors must notify the Fair Office of the animals they will sell. Deadline for this notification will be one hour after the conclusion of the appropriate show. Failure to comply results in the lightest weight animal being sold.

12. Marketing: Open competitive marketing will prevail. Animals are sold to the highest bidder.

13. Market animals do not have to be sold, however, if sold, the project is terminated. Project is terminated is defined as the animal may not be exhibited in any other show or competition.

14. Animals cannot be withdrawn from the sale after they have entered the sale ring.

15. A sale commission fee of 3% for all market animals sold will be charged by the Market Livestock Sale

Committee. This fee will be used to promote the livestock sale.

16. Arrangements for the payment, trucking, slaughter and processing of private sale animals must be taken care of by the exhibitor.

17. Only bona-fide 4-H age youth (no associate member 4-H youth) and FFA youth are eligible to sell at the Market Livestock Sale.

### UNITED STATES DEPARTMENT OF AGRICULTURE WHOLESOME MEAT ACT

The United States Department of Agriculture Wholesome Meat Act applies to the sale of market livestock sold during the Custer County Fair as follows:

1. Animals must be in good health and carcasses

free of drug or chemical residues.

2. Antibiotics and sulfonamides have required withdrawal periods.

3. Drug label directions for use and withdrawal periods.

4. If drug or other chemical residues are found in the tissue of carcasses, the entire carcass may be condemned.

If drug or other chemical residues are found in the tissue of carcasses of animals sold through sales connected with the Custer County Fair, said show will in no way be liable or responsible for the condition of carcass or sale price of animal. Exhibitor forfeits all rights to the sale price. Before administering antibiotics and/or sulfonamides, consult a licensed and practicing veterinarian, or label directions of the drug.

### AWARDS

1. Ribbons and State Fair Quality stickers are to remain with the project until the end of the Fair.

2. It is the judge's responsibility to determine the merits of all classes. NO PLACES ARE PRE-DETERMINED simply because of size of class. Champion and Blue awards will not be given, if in the opinion of the judge, the exhibit does not merit the award.

3. Awards will be given to all Grand Champion and Reserve Grand Champions from each division at the Achievement Awards Program.

4. Associate 4-H members (under age 8) will not be judged competitively. They will be recognized for their

Participation by receiving participation ribbons. Experience sharing is encouraged. Associate 4-H members will be able to exhibit at the County Fair and

other events, but not at State Fair.

5. The San Isabel Ranch provides a traveling trophy to the Grand Champion Market Steer.

6. The Fremont/Custer County Farm Bureau donates the Junior and Senior Grand Champion Master

Showmanship trophies.

7. Harold Vickerman Memorial Award sponsored by Custer County Stockgrowers Association

8. Minnie Brune Honorary Sewing Award traveling trophy to

the Grand Champion Clothing exhibitor

9. Outstanding Horseman Award
