#### **RESOLUTION NO. 18-04**

## A RESOLUTION IMPOSING STAGE II FIRE RESTRICTIONS FOR CUSTER COUNTY

WHEREAS, the Board of County Commissioners for Custer County, a political subdivision of the State of Colorado, has been asked by the Custer County Sheriff to take certain steps to protect the safety and general welfare of the citizens of the county from the risk of wildfires; and

WHEREAS, County Ordinance 15-02, adopted June 20, 2015, grants the Board of County Commissioners the authority to impose, by resolution, Stage I, II or III restrictions on open burning for all or portions of Custer County based upon a finding that the danger of forest fires or grass fires occurring in the county is high; and

WHEREAS, such a resolution must be based upon competent evidence; and

WHEREAS, a recommendation for imposition of such restrictions from the Custer County Sheriff, acting in his statutory capacity as the fire warden for the county, is considered to be competent evidence; and

WHEREAS, the Sheriff has made such a recommendation on this date and the Board of County Commissioners is satisfied that the evidence is sufficient to impose fire restrictions;

**NOW THEREFORE, BE IT RESOLVED** that, effective immediately, Stage II fire restrictions are hereby imposed for all of Custer County and shall remain in effect for a period of 30 days unless further extended by subsequent resolution. This fire ban shall be publicized in accordance with Part One, Section 8, of County Ordinance 15-02.
