RESOLUTION #08-05  
EXCESSIVE FORCE

Resolution Adopted by Custer County Board of Commissioners

WHEREAS, the County of Custer, State of Colorado, has made an application for Community Development Block Grant (CDBG) Funds from the State of Colorado; and

WHEREAS, in accordance with Section 519 of Public Law 101-144. The HUD Appropriations Act requires certain statement of assurances and certifications;

NOW THEREFORE BE IT RESOLVED that pursuant to the County of Custer being granted CDBG funds by the State, the County of Custer, by administrative act, does adopt a statement of policy prohibiting the use of excessive force by law enforcement agencies within its jurisdictions against any individuals engaged in non-violent civil right demonstrations.

Christe Feldmann, Office of Emergency Management and Len Lankford, Greenleaf Forestry and Wood Products, Inc. presented and reviewed the Community Wildlife Protection Plan, Action for 2008 Custer County.

**MOTION by Commissioner Shy, seconded by Commissioner Downey:**

Increase the county mileage reimbursement from \$.45 to \$.50 per gallon effective this date. Motion carried unanimously. Commissioner Shy instructed the Clerk and Recording Office to issue a memorandum to all department heads notifying them of the mileage reimbursement increase under their present department budget allowance.

Rusty Christensen met with the BOCC and presented the County landfill report.

The BOCC recessed at 10:25 AM. The BOCC reconvened at 10:35 AM.

Beth Lenz of UAACOG Recycling met with the BOCC and presented the Upper Arkansas Regional Recycling Program 2008 Collection Totals from January 1, through May 22, 2008.

**MOTION by Commissioner Shy, seconded by Commissioner Custer:**

Prepare a formal request to the Town of Westcliffe requesting the relocation of the town recycling bin to the County landfill facility. Motion carried unanimously.

Erlin Trakell – UAACOG Housing presented application forms to the BOCC for their signatures.

Commissioner Shy opened the Public Hearing and asked for any citizens wishing to speak. Seeing none, he closed the Public Hearing.

**MOTION by Commissioner Shy, seconded by Commissioner Downey:**

Approval to sign the following correspondence: Citizen Participation Plan, Applicant Statement of Assurance and Certification, Resident Anti displacement and Relocation Assistance Plan. Motion carried unanimously.

**MOTION by Commissioner Shy, seconded by Commissioner Custer:**

To recess for lunch. Motion carried unanimously.

The BOC recessed for lunch at 11:00 AM. The BOCC reconvened at 1:00 PM.

The department heads met with the BOCC for the monthly staff meeting. Present were: Russ Conner, Beverly Goertz, J.D. Henrich, Dawna Hobby and Ronda Post.

Mick Kastendieck, Fire Chief, outlined safety procedures and reviewed the fire protection and evacuation plan of Custer County courthouse.

Commissioner Shy proposed the department heads revise their fire evacuation plans for submission at the next BOCC meeting. Commission Downey proposed reviewing the cost of a fire alarm or siren alert for the courthouse.

Debbie Livengood, County Clerk, will research the financial advantages of replacing the copy machine on the first floor, second floor and zoning department.
