# MOTION made by Commissioner Shy, seconded by Commissioner Downey:

To authorize John Naylor to write a letter defining the County's policy for County Road 341 as follows: the road be will considered opened as a public right-of-way from Highway 96 to County

Road 329; no gates will be allowed on this road between the highway right-of-way and the south line of Section 9-22-71; from the south line of Section 9-22-71 to County Road 329, all gates that are on the road will be allowed to remain in place as long as they are unlocked; there is no implication in this policy that the County will maintain this road or remove the snow and if in the future the County decides to maintain the road, the issue of the gates will be looked at again. Motion carried unanimously.

Dave Trujillo, Road and Bridge Supervisor, presented the BOCC with a job evaluation for the new Road and Bridge Secretary, Barbara Arnone.

### **MOTION made by Commissioner Downey, seconded by Commissioner Custer:** To hire Barbara Arnone full time at 32 hours per week effective April 1, 2008 with her
