# PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS REGULAR MEETING, FEBRUARY 5, 2013

THE BOARD OF COUNTY COMMISSIONERS OF CUSTER COUNTY MET IN REGULAR SESSION IN THE COMMISSIONERS BOARDROOM.

Commissioner Lynn Attebery called the meeting to order at 9:00 AM and the Pledge of Allegiance was recited.

<u>Commissioner Attebery</u> asked if there were any public comments. Dallas Anderson asked whether local organizations using the term Custer County or District as part of their name were required to obtain approval from the commissioners or the county. <u>Commissioner Attebery</u> responded that the BOCC did not have jurisdiction regarding the terminology chosen. Mr. Anderson asked if the BOCC or the county have endorsed the Custer County Conservation District (CCCD). The Board responded that the CCCD was not sanctioned by the county. Terre Davis said she was in attendance to participate in the review of the zoning fees. The Board agreed to address the Planning and Zoning Fees at this time.

Jackie Hobby, Planning and Zoning Director joined the meeting and presented the proposed zoning fees as follows:

## MOTION by Commissioner Shy, seconded by Commissioner Butler:

To approve the zoning fees as presented. The motion carried unanimously.

Terre Davis said that any cost for a home occupation should not be referred to as a charge, tax or permit. She suggested a registration fee that would include advertisement of the business on the Custer County web page. She said by doing so the business owner would feel they are benefiting from the registration fee. She further suggested that the county should refrain from using the term tracking of the registered home occupations and focus on the advertising benefit that a registration would provide. Jean Schmutzler said that if the county was experiencing budget restrictions for 2013, the BOCC should have reconsidered approving the 1.5% increase for the county employees instead of raising the zoning fees. Commissioner Attebery responded that the fees proposed by the Planning and Zoning Director were reduced from the previous years. The Board agreed that the planning fees in Custer County were substantially lower than other counties in the state. Robin Schmultzler asked if he needed a permit to dig a hole on his property. Commissioner Shy said that a permit would not be necessary. He said that excavation permits were required for the addition of structures or additions to the footprint of an existing structure.

Ileen Lemons, Clerk/Treasurer, Town of Silver Cliff, Clerk met with the BOCC and said that the Town of Silver Cliff and the Town of Westcliffe are under the 81252 zip code. She said because of this the Town of Silver Cliff has been losing sales tax to the Town of Westcliffe. Her research revealed that a drop down list for the towns could be added to the 81252 zip code. In order to do this the US Postal Service is requiring notification from the BOCC confirming that the Town of Silver Cliff, Colorado and the Town of Westcliffe, Colorado are incorporated towns lying within the boundaries of Custer County and the Colorado Zip Code 81252.

## MOTION by Commissioner Shy, seconded by Commissioner Butler:

To approve the preparation of correspondence addressing the issue. The motion carried unanimously.

Jackie Hobby, Planning and Zoning Director met with the BOCC and the following topics were discussed.

# MOTION by Commissioner Shy, seconded by Commissioner Butler:

To approve and issue a permit violation notice on File #102-36-922. The correspondence will be sent by certified mail. The motion carried unanimously.

Ms. Hobby announced that the Planning Commission has scheduled two workshops to go over the draft Zoning Regulations. Those workshops are scheduled on February 6 and February 13, 2013 from 1:00 PM to 4:00 PM. Ms. Hobby stated that the Board of Zoning Adjustment has a setback variance and housekeeping meeting/hearing today at 1:00 PM in the courtroom. Ms. Hobby said that the Planning Commission has not met in 2013 and therefore has not appointed a chairman. She said that Vic Barnes has been the chairman in 2012 and asked for guidance on the issue. Commissioner Attebery responded that Mr. Barnes would continue to preside over the meeting as the acting chairman until one has been appointed.

The BOCC agreed to schedule a discussion on Amendment 64 at the March 4, 2013 BOCC meeting. The Board will notify Sheriff Jobe and Ms. Hobby of the topic.

<u>Commissioner Attebery</u> stated that the Former County Surveyor Project CR390 topic would be tabled at this time.

Virginia Trujillo, Treasurer met with the BOCC and gave a report. The beginning balance on December 1, 2012 was \$3,004.332.35 and the ending balance on December 28, 2012 was \$2,739,185.73

#### MOTION by Commissioner Attebery, seconded by Commissioner Butler:

To accept the Treasurer report for December 2012 as presented. The motion carried unanimously.

Virginia Trujillo, Treasurer presented the report for January 2013. The beginning balance on January 1, 2013 was \$2,739,185.73 and the ending balance on January 31, 2013 was \$3,245,131.09.

# **MOTION** by Commissioner Shy, seconded by Commissioner Attebery:

To accept the Treasurer report for January 2013 as presented. The motion carried unanimously.

Ms. Trujillo presented the quarterly Public Trustee report to the Board for review.

Ms. Trujillo said that the County Finance Officer is requesting a non-operating transfer (loan) of \$80,482.84 from the In Lieu of Tax Fund to the Self-Insurance Fund. She presented the paperwork for the Boards approval.

## MOTION by Commissioner Attebery, seconded by Commissioner Butler:

To approve the non-operating transfer loan as presented. The motion carried unanimously.
