PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS REGULAR MEETING, JANUARY 20, 2015

THE BOARD OF COUNTY COMMISSIONERS OF CUSTER COUNTY MET IN A REGULAR MEETING IN THE BOARDROOM.

Commissioner Kit Shy called the meeting to order at 9:00 AM and the Pledge of Allegiance was recited.

Regional Board Appointments

Commissioner Shy asked how many people in the audience were here for the public comment period. The majority of those present raised their hands. Commissioner Shy said that the public comment period was generally limited to a few minutes and if the topic was going to take longer, the matter would need to be scheduled as part of an upcoming agenda. Several individuals started to voice their disapproval and concerns regarding the BOCC's decision to award the 2015 legal publication to the Sangre DeCristo Sentinel at the January 13, 2015 BOCC meeting. They would like the commissioners to withdraw the appointment of the Sangre DeCristo Sentinel and continue county legal publications with the Wet Mountain Tribune. Commissioner Shy said that if the individuals wanted the opportunity to comment on the awarded appointment, the topic would be scheduled as an agenda item for a future BOCC meeting. The BOCC agreed to schedule a Special Meeting on January 29, 2015 beginning at 9:00 AM to allow the public to share their comments. In an effort to accommodate the number of attendees, the meeting will be held in the court room of the Custer County courthouse.

MOTION by Commissioner Attebery, seconded by Commissioner Kattnig:

To approve a change in the BOCC calendar for 2105 to include a Special BOCC Meeting on January 29, 2015 to hear comments regarding the appointment of the Sangre DeCristo Sentinel as the County's 2015 Legal Publication. The motion carried unanimously.

Jim Little, Publisher of the Wet Mountain Tribune commented for the record that the county was in violation of the Colorado State Statute requiring that legal notice are placed on a statewide website. He said that as of last evening the statewide website did not include any Custer County, CO. legal notices.

Cindy Howard expressed concern regarding the contents of the social media on the Custer County Community face book page. She said that she would like to discuss it further with the BOCC at a future date.

<u>Commissioner Shy</u> said that he will be attending the Colorado Counties Incorporated (CCI) steering committee meetings on January 22 and 23, 2015.

<u>Commissioner Kattnig</u> said he attended the new commissioner orientation at CCI on January 14, 15 and 16, 2015.

<u>Commissioner Attebery</u> said that the Human Resource/Finance Department has been faced with additional responsibilities and functions as a result of the 2015 governmental revisions. He stated for the record that Dawna Hobby, Human Resource/Finance Manager used a portion of her January 19, 2015 paid holiday and came into work to complete these tasks. <u>Commissioner Attebery</u> also said that Dave Post, Scales and Maintenance came into work on Saturday, January 17, 2015 to accommodate a rancher with certified weight scale tickets. He expressed appreciation to these employees.

Commissioner Attebery said that the BOCC has received a correspondence from Bob Dreher, Executive Committee of the American Legion Post #170 expressing concern regarding the air quality in the County Resource Center Building. Commissioner Attebery stated that when the BOCC determined the 2015 points of contact for the various county departments at the January 13, 2015 meeting, the County Resource Center Building was inadvertently listed under his name. He said that on that date he had proposed that Commissioner Kattnig be the initial point of contact for the facility. The Board agreed that Commissioner Kattnig would be the point of contact for the Resource Center Annex. Commissioner Kattnig expressed concern regarding the health issues of a public building and will investigate the issue as soon as possible.
