# **NEW AND OLD BUSINESS**

### **SENIOR CENTER**

John Stevens, with the Custer County Senior Citizens Center, gave the BOCC a progress report on projects they have been working on. They are trying to get the Senior Center ADA compliant. He also requested that the board restore the 17% (\$680) that was taken out of their Conservation Trust Fund request for 2016. Commissioner Attebery asked him to submit a request in writing.

#### REPEATER IGA

John Decker, with the Wet Mountain Fire Protection District, requested that the BOCC develop an IGA for the Verdemont and Deer Mountain repeaters. The IGA would involve the County, the sheriff's office, the fire department, EMS, road and bridge, and the school. Assistant Attorney, Clint Smith, will work on putting together an IGA.

#### DISTRICT ATTORNEY'S OFFICE

Molly Chilson, Assistant District Attorney, met with the BOCC to give them an update on their office. She asked the board if they would like for someone to come to a board meeting to give them regular updates. Commissioner Kattnig stated he thought that sending them updates in writing would suffice. She also gave the board a handout on marijuana issues they have been dealing with. She stated that both Park and Fremont counties now have marijuana ordinances.

### JUDICIAL ACCESS

Mike Halpin, Deputy Sheriff and Courthouse Security, met with the board to request the funds to add a door in the courtroom that would provide the court employees and judges with secure access between the court offices and the judges bench. He would also like to extend the wall that comes off of the judge's bench to make the area where court staff and judges sit more secure. The board asked him to get some figures together.

#### LETTER OF SUPPORT

The BOCC received a letter from the San Carlos Ranger District asking for a letter of support for a grant they are applying for that would help them continue working on ATV and motorcycle trails on public lands.

MOTION by Commissioner Attebery, seconded by Commissioner Kattnig, to write a letter of support for the San Carlos Ranger District OHV Trails Grant 2017. Motion carried unanimously.

MOTION by Commissioner Attebery, seconded by Commissioner Kattnig, to pay the bills as presented for the month of September 2016. Motion carried unanimously.
