## **ATTORNEY ITEMS**

Assistant County Attorney, Clint Smith, received an email requesting a road name change in Aspen Ridge; he met with Steve Chandler with Wet Mountain Broadcasting regarding the antenna lease at the SAR building; he filed the Motion to Dismiss with the court for the Hamilton/Halpin/County lawsuit; and he went over the Statewide Internet Portal Authority (SIPA) agreement and found everything in order.

# **HUMAN SERVICES CONTRACTS**

#### JOHN NAYLOR - SERVICE RECOGNITION

Assistant County Attorney, Clint Smith, presented the board with Resolution 16-16 recognizing the many years of service that County Attorney, John Naylor, has given the county. John has been the County Attorney since January 5, 1970. Commissioner Shy read the resolution into the record.

# LIQUOR LICENSE RENEWAL/LODGE AT SAN ISABEL

Clerk and Recorder, Kelley Camper, met with the board to request the approval of the liquor license renewal for the Lodge at San Isabel.

MOTION by Commissioner Shy, seconded by Commissioner Kattnig, to approve the liquor license renewal for the 3.2 license for The Lodge at San Isabel. Motion carried unanimously.

# SHERIFF'S OFFICE VEHICLE PURCHASE

Sheriff, Shannon Byerly, met with the board to let them know that he has funds left over from 2016 and he would like to use some of those funds to purchase a new sheriff's office vehicle. The vehicle that he is replacing would go to another county office.

MOTION by Commissioner Attebery, seconded by Commissioner Kattnig, to approve the 2016 purchase of a new vehicle for the Sheriff's Department and that the vehicle that is to be replaced stays in the fleet. Motion carried unanimously.
