MOTION by Commissioner Flower, to request a bid from Oak Disposal for a three-yard dumpster with twice per week pickup. Motion carried unanimously.

Commissioner Flower read a letter of resignation from Office of Emergency Management Deputy Director, Meredith Nichols.

MOTION by Commissioner Flower, to accept Meredith Nichols letter of resignation, effective immediately. Motion carried unanimously.

#### SHERIFF'S VEHICLE DONATION TO LAS ANIMAS COUNTY

BOCC Administrative Assistant, Brenda Gaide, explained to the board that County Sheriff, Shannon Byerly, had to leave the meeting, but he no longer needed to discuss this matter. Commissioner Flower explained that Las Animas County recently lost two of their Sheriff's vehicles in an accident. Sheriff Byerly was taking two of his vehicles out of service and wanted to discuss donating one of the vehicles to Las Animas County. There was further discussion regarding using one of the vehicles at the airport as a courtesy vehicle.
