ATTEBERY explained the Special Use Permit process to the members and audience. The hearing is scheduled for October 4, 2005, at 1:00 in the Courthouse. ATTEBERY also reminded the applicant that he is scheduled to make a presentation to the Regional Planning Commission next Wednesday, September 14, 2005, at 1:00 P.M. in the Courtroom.

COOK presented the attached information to the boards.

DONLEY asked what the boundaries of the Rye Fire Protection District were and it turned out that this proposal is not located in any fire district. DEARBORN asked if he had considered having his own ambulance and COOK said there would be an EMT on staff and that all staff would be trained in CPR and advanced first aid. SHY asked about the phones and COOK stated that there are two lines on the property and that is all they will have.

BARNES asked about the water situation and COOK explained that he is planning to install a 5000 gallon underground tank and haul water from a legal water source like Florence, Westcliffe or Rye. The proposal may use a commercial water delivery service and will investigate a commercial well in the future.

COOK said he has thought about leasing the mountain behind them from the Forest Service for expansion in a few years, if it is deemed feasible. COOK said he has no neighbors that are close.

COOK explained to the boards that the chairlift will have to be permitted and inspected the State Tramway Board. COOK said that the contractor and design engineer is DLM Enterprises.

The Planning Commission requested a profile of the lodge building to include the height and the Engineer-designed septic system plan.
